Winter safety and weather - This winter has been mild so far, however, there is still a chance of cold weather. Please follow the Staffordshire Police advice about driving in snow and icy conditions:

- Keep checking the local weather forecast for warnings about icy or snowy weather.
- Stay with your car at all times when defrosting it to prevent your car from being stolen.
- Clear all snow and ice from your windows to ensure sure you are able to see.
- Remove all snow that might fall off into the path of other road users and ensure your lights are clean and number plates are visible and legible.
- Take care on the road and allow extra time for your journey.
- Check your planned route is clear of delays.

A message from PCSO Lloyd and PCSO Price - As local officers engaging with residents it has become apparent that the number of issues reported and the number of issues that can be viewed on social media do not correlate. Police levels are dependant upon jobs reported so it is essential that <u>all</u> concerns are reported via the most appropriate route (101 or 999). Social media comments do not generate an incident report. Please see the Staffordshire Police 101 non-emergency guidance below: Some examples of when to call 101:

- if your car has been stolen
- if your property has been damaged or vandalised
- where you suspect drug use or dealing
- if you want to report a minor traffic collision
- if you want to provide information about crime
- if there is no immediate danger to life
- if the crime is NOT in progress
- if the offender is NOT nearby

Calls to 101 (from both land lines and mobile networks) cost 15 pence per call, no matter what time of day you call, or how long you are on the phone. To contact the Staffordshire Police from abroad, call (+44) 1785 236211

Report a crime anonymously: Call independent crime-fighting charity Crime stoppers anonymously on 0800 555 111 or through their Anonymous Online Form at Crimestoppers. No personal details are taken, information cannot be traced or recorded and you will not go to court.

If there is a significant incident affecting the force we sometimes set up a Casualty Bureau - this is a dedicated number for those who have family members affected by the incident. The number will be published on our social media and by the media. This allows the contact centre to separate 'normal' calls from the incident specific calls.

Appeal for Community First Responders

Wheaton Aston Community First Responders (CFRs) are appealing for new members. CFRs are volunteers trained by the Ambulance Service to respond to 999 requests for medical assistance in their locality. When the scheme was first started it had twelve CFRs but over the years as people have moved away or left through other commitments the numbers have dwindled so that only two active responders remain.

New recruits should have a clean driving licence, be reasonably fit and aged between 18 and 70. They will need to complete a training course with West Midlands Ambulance Service. New members will be supported by an experienced responder until they are confident they are able to respond on their own.

The scheme is well supported financially by the community but without members to book on call it could soon no longer be viable. David Leaper, scheme coordinator, is hoping to hear from people who live or work in the area and agree to book on call for a minimum of 24 hours per month. PARISH COUNCIL ELECTIONS - 2ND MAY 2019

Why is it important that everyone votes in local elections?

Did you know that your local councillors are consulted on nearly everything that happens in your area? They take an active part in influencing what services are and are not provided - and that affects you and your family!

Parish and Town Councils are responsible for many things like: bus shelters, litter bins, local halls and community centres, parks, public clocks and footpaths to name but a few. They are also consulted on planning applications, highway improvements, street signs, grant funding and projects that affect where you live and what facilities your community has or receives. Local councils are delivering more services for residents than ever before and with District/Unitary/County Council reviewing their services, Parish and Town Councils will be in a position to do even more in the future.

Everything we come into contact with on a daily basis affects how we feel and what we do - so how much effort do you actually make to get your opinions known? Voting in local parish and town council elections takes so little time, but will have a daily impact on you for the next four years, because councillors remain in office for a four year term and their decisions affect the future for your whole community. If you leave voting to others your opinions and wishes will not be heard and simply by voting for a candidate you feel will reflect your view sends a clear message of your opinion to the decision makers.

It is said 'people get the local council they deserve'. Do you know who in your community is standing for election and what they hope to achieve? The names of your councillors should be on your parish notice boards, in local post offices or displayed around your community. If you cannot find this information locally your District/Unitary Council may be able to advise you. Councillors live side by side with you in your community; they are the most local level of government, being easily contacted and directly answerable to the community every time they walk out of their front doors. They raise money primarily through your council tax to administer their decisions and others will and their views may change your life. Have a voice - vote in the local elections on 2nd May 2019 you need to be sure that you have voted for the right people to look after your community. If you do not vote,

ARE YOU INTERESTED IN BECOMING A PARISH COUNCILLOR?

Be a voice for your community

Want to stand up for where you live or work and make real changes? If you are over 18, then you are probably eligible to be a parish councillor for the parish where you live or work, tackling issues that matter to your local area – like the provision of leisure facilities, youth projects, community centres and community transport, festivals and celebrations.

There are 180 parish and town councils in Staffordshire. Councils strive to provide services efficiently and increasing numbers are taking on delegated powers from other tiers of local government. Responsibilities can vary from parish to parish, but services they can take on may include street lighting, parks and open spaces, public toilets.

Parish council meetings are generally held monthly or perhaps once every other month, depending on the size of the Parish and the range of activity. With few exceptions the proceedings at all meetings are open to the public in order that the decisions being made on the work of the council and the reasons behind them are made fully apparent. Attending a council meeting is the best way of finding out what it does, so see your village noticeboard or give the council a call and find out when the next meeting is due.

Staffordshire's town and parish councils will be holding their next elections on 2nd May 2019. If you wish to stand for election you need to submit your nomination by 4pm on 3rd April 2019 to your local District or Borough Council elections officer.

What does a councillor do?

Most people's impression of what a councillor does is that they just attend council meetings and nothing could be further from the truth. The duties and pleasure, of being a local councillor are many and varied, however it is the ordinary day to day contact with local people in their own community that is the most important part of being a councillor. A Parish or Town Councillor signs a Declaration of Acceptance of Office and thereby undertakes to observe an ethical Code of Conduct when dealing with matters on behalf of the community. A councillor also completes a register of interests.

Listening: One of the most important tasks of a Parish or Town Councillor is listening to and understanding the views of people in their community. Many public bodies or organisations acknowledge this is the hardest information for them to capture and they in turn use the skills and local knowledge of the parish or town council for advice to assist and inform their services.

Meetings: A councillor agrees to attend all meetings (reasonably possible) that he or she is summoned to. In a smaller council this may only require one meeting of full council a month (there are however a few small councils that still only meet once every two months). In medium and larger councils however, along with full council meetings, there are further committee meetings or working groups. Most meetings are held in the evening but some committees and group representation may be during the day. Some of these committees may include planning, finance and staffing, properties or policy. Where committees are used however the council usually consists of a larger number of councillors and therefore each councillor is only expected to serve on one or two committees.

Representation: Parish Councils also need representation at other local government meetings or on local bodies/organisations and councillors may be asked to serve on certain groups or attend functions on behalf of the parish council. Councillors act as ambassadors for their community keeping everyone aware of local needs and concerns and reporting back on District/Unitary, County and regional changes. Councillors represent the voice of their community as a whole, whilst being aware of and considerate to, specific minority needs.

Ceremonial Duties: In some larger councils there will be times when councillors are asked to attend civic functions as part of their duty to the community. This may entail Remembrance Parades, civic dinners or attendance at public functions such as the Christmas Light Switch on to name but a few.

Extra skills: Through all of these functions councillors will draw on their own skills and experiences and it is the sharing of these skills that makes a strong team. Parish and Town Councils provide a focus for the community to identify concerns and projects and endeavour to solve them locally themselves. Councillors working as a team will need to deal with employment issues, budgeting, asset management, staff management, project management or grant funding and probably lots more if they are creative and involved. All councils must be aware and owe a duty to their community to manage staff considerately, whether it is employing one parish clerk or a whole host of office and grounds' maintenance staff. Accounts must be kept and whilst the clerk (or Responsible Financial Officer) will be employed to carry out this duty, councillors together as a team are responsible for the financial decisions made and implemented. A clerk is employed to advise and seek advice on behalf of councillors to assist them in their decisions. Councillors are there to consider the information gathered and make a group decision on all matters. No individual councillor is responsible for any single decision. This is democracy at its best.

Training and support: Training is available to any council, large or small. Legislation allows for councils to pay for training and ongoing training for councillors is sound business management. The County Secretary for the Association of Local Councils in your area will be able to provide details of professional training programmes designed specifically for councillors, see the useful contacts section in this pack for contact information.

Responsibility: All councillors are expected to abide by the Parish Councils Code of Conduct. Each local council must adopt and publicise a Code of Conduct that is in line with the Nolan principles. The Code deals with councillors obligations about their conduct, including the registration and disclosure of their interests.

If you would like to know more about parish councils or becoming a parish councillor, a useful booklet entitled "The Good Councillors Guide" is available in electronic format from your local council.
